| | Original application form duly completed and signed. Note: For children under 18 years old, both parents must sign the application/declaration form/questionnaire. Passport copies of the father and mother have to be attached. | |
| | Ensure that 3 fields are signed in the application form (field no.37, Page 3 Applicable in case of multiple-entry visa is applied for/bottom box and Page 4 – signature box). | |
| | Original passport & a copy of bio-page (must be at least 3 months valid after the intended stay). | |
| | Note: Bahrain resident permit (for non-Bahraini nationals) must be valid until the date of return. The passport must contain the signature or the fingerprint of the holder and 2 free pages. | |
| | 1 recent passport photograph Note: Passport size with white background; must be recent (not older than 6 months) and sized 45– 50mm high and 35–40mm wide. | |
| | Proof of relation (e.g. birth certificate and/or marriage contract) | |
| | Note: Marriage contract must be updated and registered in the EU country). | |
| | For descendants over 21 and ascendants: proof that you are economically dependants of EU/EEA citizens | |
| | Passport copy of spouse (EU/EEA citizen) | |
| | Any proof that you are travelling or joining the EU/EEA citizen (Any proof that the EU/EEA citizen is living in Spain / either flight or hotel reservations which shows both the name of the EU citizen and applicants). | |

Please note:

- This visa is in case he/she is travelling or joining the EU/EEA citizen.
- The visa must be applied for either in person or through a representative (applicable for below 12 years).
- All documentation must be submitted in English or Spanish language
- For children registered in a parent's passport, a separate application form has to be submitted.
- Original documents must be presented; additional photocopies may be required
- The Embassy of Spain has a right to ask any other additional documents it considers necessary, or may call the applicant for an interview. If the visa application is refused, the reason will be provided as per Schengen Immigration Rules. Visa fee is free-of-charge (gratis) however; service fee is non-refundable.
- Head coverings is not permitted except for religious reasons, but facial features from bottom of chin to top of forehead and both edges of applicant's face must be clearly shown.

Declaration

I have been informed that an application without a complete set of documentation according to above mentioned checklist may result to the rejection of my visa application. The Embassy of Spain reserves the right to ask for an additional supporting document and does not guarantee the issue of visa.
